# **Categories of Membership**

Members, it is important to know which classification of membership relates to your circumstance and to notify the club if your circumstances change e.g. town to remote or remote to retired.

### (a) **Town Member**:

A member who either usually resides and or carries on his business or profession within a 20km radius of the Association's premises situation at the corner of Margaret and Mylne Street Toowoomba.

### (b)Country Member:

A member who usually resides and or works outside a radius of 20km from the Club.

### (c)Life Member:

A member who has rendered special services to the club and whose nomination for Life Membership shall be passed by the committee and confirmed by a vote of four – fifths of the Members present at a General Meeting.

### (d)Honorary Member:

During their stay in Queensland, to the Governor General, State Governors and Members of their staff, and the Judges of the Courts of Queensland and their associates when on circuit and Officers in charge of Defence Establishments on the Darling Downs. Other circumstances apply to Honorary Members.

#### (e) Absent Member:

A member intending to leave Queensland. Annual Subscription shall be such sum as shall be determined by the Management Committee.

#### (f) Remote Member:


A member who usually resides and carries on his business or profession outside a radius of 250km of the Club premises.

#### (g)Over 40 Years Member:

A member shall be eligible to make application in writing to the committee for a change of classification of his membership.

### (h)Junior Member:

A member who is 35 years of age or under.


